Present were Council Vice President Toni Bell; Council Members James Huber, James Garman, Bonnie Crawford, Justin Hummel and Vince DeMelfi; and Town Manager/Secretary/Treasurer Lisa Dooley. Absent was Mayor William Kreisher.

MAYOR'S REMARKS

APPROVAL OF PAYMENT TO DON E. BOWER FOR PROFESSIONAL SERVICES REGARDING THE REHABILITATION APRON PHASE II CONSTRUCTION PROJECT

On a motion by J. Hummel, seconded by B. Crawford, and voted on 5 'yes' votes and 1 'no' vote (J. Huber), Council approved payment to Don E. Bower in the amount of \$12,946.98 for professional services in regards to the Rehabilitation Apron Phase II Construction Project.

Huber), Council approved payment to Delta Airport Consultants, Inc. in the amount of \$2,135.23 for professional services through December 29, 2019 in regards to the Rehabilitation Apron Phase II Construction Project.

On a motion by V. DeMelfi, seconded by J. Huber, and voted on unanimously, Council approved the 2019 Tax Collector official reports.

On a motion by J. Hummel, seconded by B. Crawford, and voted on unanimously, Council approved amending the agenda to discuss the employment status of the Chief of Police.

On a motion by J. Garman, seconded by J. Huber, and voted on unanimously, Council approved the termination of at-will employee, Chief of Police William Gelgot effective immediately due to a vote of no confidence during his six-month probationary period.

On a motion by J. Garman, seconded by J. Hummel, and voted on unanimously, Council approved Lewis Carl as Acting Chief of Police at a weekly rate of \$1,773.86, effective immediately and lasting up to three months.
