# CITIZEN TO BE HEARD – CHARLES WAGNER

Charles (Chuck) Wagner posed questions on the non-student rental inspection ordinance that was approved for advertising. He believes the town is increasing the size of government with this ordinance rather than reducing as other governments are doing. There are already remedies on the books for the code officers to inspect properties that tenants/residents believe are unsafe. He asked if any citizens came forward and asked for this ordinance. D. Levan said she had heard from two. W. Kreisher stated he had personal and professional experience observing the conditions of the non-student rental stock. He does not feel tenants relay their concerns for fear of retribution. Mr. Wagner compared the proposed ordinance with the regulated rental ordinance. He is urging Council to vote "no" when it comes before them for adoption. Landlords Ed Sabo and Eric Bower spoke in favor of the ordinance.
