

A regular meeting of Bloomsburg Town Council was held Monday, May 23, 2011, beginning at 7:00 p.m. in Council Chambers, Town Hall, 301 East Second Street, Bloomsburg, PA. Present were Mayor Daniel Knorr, presiding; Council Members Paul Kinney, Sylvia Costa, Kathy Shepperson, W. Carey Howell and William Kreisher; Town Administrator Carol Mas and Solicitor Jack Mihalik. Absent was Council Member Diane Levan.

#### PROCLAMATION – RELAY FOR LIFE DAY

Mayor Knorr proclaimed June 10-11, 2011 as Relay for Life Day in the Town of Bloomsburg and presented the Proclamation to Patti Zwalkuski and Norma and Charles Shultz.

#### MAYOR'S UPDATE

Mayor Knorr announced upcoming meetings; informed Council of the planned technology walk through; thanked all the volunteers who helped with the toddler park; showed the No Place for Hate sign and distributed PennDOT's position on the traffic control message board.

#### APPROVAL OF MAY 9, 2011 COUNCIL MEETING MINUTES

On a motion by P. Kinney, seconded K. Shepperson and voted on unanimously, Council approved the May 9, 2011 Council meeting minutes without any additions for corrections.

#### APPROVAL OF ADVERTISING TOWN ADMINISTRATOR/SECRETARY-TREASURER POSITION

On a motion by P. Kinney, seconded C. Howell and voted on unanimously, Council approved advertising for the position of Town Administrator/Secretary-Treasurer in several media outlets.

#### APPROVAL OF HIRING PART-TIME TEMPORARY SEASONAL REGULATED RENTAL HOUSING INSPECTOR

On a motion by C. Howell, seconded by D. Knorr and voted on unanimously, Council approved hiring John Evert as a part-time temporary seasonal regulated rental housing inspector at a rate of \$10.71 per hour.

#### APPROVAL OF PAYMENT OF INVOICE FROM PETERS CONSULTANTS, INC. FROM CDBG PROGRAM

On a motion by P. Kinney, seconded by S. Costa and voted on unanimously, Council approved payment to Peters Consultants, Inc. in the amount of \$2,212.45 from the CDBG Program for construction administration services related to the Phase IV Main Street Lighting Project.

#### APPROVAL OF ACCEPTING TRANSPORTATION ENHANCEMENT GRANT

On a motion by S. Costa, seconded by C. Howell and voted on unanimously, Council approved accepting a Transportation Enhancement Grant in the amount of \$368,000 for the Phase V Main Street Lighting Project.

The meeting adjourned into Executive Session at 7:17pm to discuss an appeal of a Zoning Hearing Board decision with Solicitor Mihalik and police union negotiations. The meeting reconvened at 7:41pm.
