

A regular meeting of Bloomsburg Town Council was held Monday, June 23, 2014, beginning at 7:00 p.m. in Council Chambers, Town Hall, 301 East Second Street, Bloomsburg, PA. Present were Mayor Sandy Davis, Council Members W. Carey Howell, Diane Levan, Sylvia Costa, Bill Kreisher, Fred Trump and Eric Bower; Town Administrator William Lowthert; Assistant Town Administrator Lauren Martz; Chief of Police Roger Van Loan; and Environmental Services Coordinator Charles Fritz;. Absent were Superintendent of Public Works John Barton; Code Enforcement & Zoning Administrator Ed Fegley; Director of Finance Lisa Laboskie; Solicitor Jack Mihalik, and Fire Chief Bob Rupp.

CHECK PRESENTATION-BLOOMSBURG UNIVERSITY COMMUNITY FOUNDATION

Jerome Dvorak of the Bloomsburg University Community Foundation presented \$10,000.00 to the Town of Bloomsburg in the form of two (2) \$5,000.00 checks to Mayor Sandy Davis. The first \$5,000.00 check will be used towards the purchase of a new fire truck. The BU Foundation has pledged to donate \$5,000.00 annually for five (5) years totaling \$25,000.00 towards the purchase of a new fire truck. The second \$5,000.00 check is intended to be used towards the Phase VI street lighting project which will connect the downtown street lights up to the University via East Second Street otherwise known unofficially as "College Hill."

On a motion by B. Kreisher, seconded by F. Trump and voted on Six (6) (B. Kreisher, F. Trump, C. Howell, S. Costa, D. Levan, and E. Bower voting "Yes") to One (1) (S. Davis "Abstaining"), Council approved the June 9, 2014 Council meeting with no additions or corrections.

APPROVAL OF STREET VENDOR PERMIT

On a motion by C. Howell, seconded by D. Levan and voted on unanimously, Council approved the street vendor permit for space #1 for Emily Zenzel of Em's Pink Wieners from 7/01/14-12/31/14.

APPROVAL OF THE PURCHASE OF SIX (6) WIRE MESH CONTAINERS

On a motion by F. Trump, seconded by S. Costa and voted on unanimously, Council approved a quote from Crone Metal Works in the amount of \$16,800 to fabricate Six (6) wire mesh containers.

APPROVAL OF ACCEPTING HOME INVESTMENT PARTNERSHIPS PROGRAM GRANT

On a motion by C. Howell, seconded by D. Levan and voted on unanimously, Council accepted the HOME Investment Partnerships Program Grant through DCED in the Amount of \$1,000,000.

APPROVAL OF RESIGNATION OF MICHAEL PERACOVICH FROM THE SHADE TREE COMMISSION

On a motion by S. Costa, seconded by C. Howell and voted on unanimously, Council accepted the resignation of Michael Peracovich from the Shade Tree Commission with regret.

APPROVAL OF RESIGNATION OF JODI BRADEN FROM THE NORRIS E. ROCK MEMORIAL SWIMMING POOL OPERATIONS BOARD

On a motion by S. Costa, seconded by D. Levan and voted on unanimously, Council accepted the resignation of Jodi Braden from the Norris E. Rock Memorial Swimming Pool Operations Board with regret.

APPROVAL OF DONATING 2014 VENDOR FEES FROM THE JULY 4TH EVENT TO THE VETERANS MEMORIAL PROJECT

On a motion by S. Costa, seconded by C. Howell and voted on unanimously, Council approved donating the 2014 Vendor Fees from the Town's planned July 4th event to the Veterans Memorial Project.

CITIZEN TO BE HEARD

Joe Martarano, 259 East Tenth Street, would like the Town to include on the Council agenda if an item currently being considered for purchase was a budgeted or non-budgeted item. B.
