# MAYOR'S UPDATE

Mayor Knorr updated Council on the CDBG Disaster Relief funds. Bill Lowthert and Bill Seigel met with Rich Kisner and found out that municipalities will be able to apply in the fall to the County to be considered but funds won't be available until mid 2013. If the Town proceeds with the demolition of the 900 block now, the Town can't be reimbursed with these funds when they become available. Mayor Knorr gave the following three options to Council: put the 900 block on hold until the funds become available, discuss how to fund the 3% match tonight or discuss it at the next Administrative/Finance Committee meeting next Tuesday, July 3<sup>rd</sup> and forward a recommendation to Council for the meeting on July 9<sup>th</sup>. ### APPROVAL OF HIRING DAVID BOWMAN AS A FULL-TIME POLICE OFFICER

On a motion by S. Costa, seconded by D. Levan and voted on Six (6) (S. Costa, D. Levan, D. Knorr, C. Howell, B. Kreisher and E. Bower voting "Yes") to One (1) (F. Trump voting "No"), Council approved hiring David Bowman as a full-time officer for the Bloomsburg Police Department with a tentative start date of July 15, 2012.

L. Sokoloski reported that trick-or-treat night in the Town of Bloomsburg will be held on Wednesday, October 31<sup>st</sup> from 6:00pm to 9:00pm.

## APPROVAL OF PURCHASE OF HOSE AND ADAPTORS FROM SUSQUEHANNA FIRE EQUIPMENT

On a motion by F. Trump, seconded by D. Levan and voted on unanimously, Council approved the purchase of hose and adapters in the amount of \$6,002 from Susquehanna Fire Equipment Company for the Bloomsburg Fire Department. It was noted that his was a budgeted purchase.

# APPROVAL OF FREE PARKING ON MAIN AND EAST STREETS WITH TWO-HOUR PARKING LIMIT ENFORCED FOR ANNUAL SIDEWALK SALES

On a motion by F. Trump, seconded by D. Levan and voted on unanimously, Council approved free parking on Main Street from West to East Streets and on East Street from Main to Third Streets with the two-hour parking limit enforced for the Annual Sidewalk Sales being held on July 12-14, 2012. D. Knorr asked Downtown Manager Adrienne Mael if she plans to bag the meters and she indicated yes.
