APPROVAL OF JULY 9, 2018 COUNCIL MEETING MINUTES

On a motion by F. Trump, seconded by B. Crawford, and voted on unanimously, Council approved the July 9, 2018 Town Council meeting minutes with the following corrections to add: Adding "as needed" to the motion approving Brian Kerstetter to provide municipal legal services and correcting the motion approving the purchase of a security gate to say "approving purchase of a security gate motor and remote control".

APPROVAL TO ACCEPT THE RESIGNATION OF COLLEEN CAUTO AS A FINANCE CLERK, EFFECTIVE JULY 10, 2018

On a motion by B. Crawford, seconded by J. Garman, and voted on unanimously, Council approved to accept the resignation of Colleen Cauto as a Finance Clerk, effective July 10, 2018.

APPROVAL OF QUOTE FROM SOKOL INC. FOR THE CONSTRUCTION OF NEW CURB CUTS AT INTERSECTIONS IRON & 3RD STREET AND IRON & 4TH STREET

On a motion by B. Crawford, seconded by J. Garman, and voted on unanimously, Council approved a quote from Sokol Inc. in the amount of \$10,490.00 for the construction of new curb cuts at intersections Iron & 3rd Street and Iron & 4th Street.

APPROVAL OF PAYMENT TO DON E. BOWER CONSTRUCTION FOR THE LIGHTSTREET ROAD ARC PROJECT

On a motion by F. Trump, seconded by B. Crawford, and voted on unanimously, Council approved payment to Don E. Bower Construction in the amount of \$100,329.69 for the Lightstreet Road ARC Project to be paid for via Bloomsburg University CGA and PennDOT.

APPROVAL OF 2018 ROAD PAVING PROJECT TO SOKOL INC.

On a motion by B. Crawford, seconded by F. Trump, and voted on unanimously, Council approved the 2018 Road Paving Project in the amount of \$141,947.00 to Sokol Inc.

J. Garman noted that the Town Park Improvement Association's annual Cake and Ice Cream Festival is set to be held on August 9, 2018.
