## CITIZENS TO BE HEARD – Rich Kisner, Ty Williams, and Diane Levan

Rich Kisner wanted to share an opportunity for the Town of Bloomsburg and the Bloomsburg citizens about a TIF Feasibility Study the Community Strategies Group pf the Columbia County Housing Corporation is planning to do in the Town. The purpose of the study is to gather information that will be beneficial to continue projects that are currently in the making, such as, further housing opportunities, a potential parking garage, and hotel. The feasibility study's cost will be completely covered by different resources that have no affiliation with the Town.

Ty Williams expressed his thought about the benefits of a courtesy car for the Municipal Airport. He gave examples of other airports which have courtesy cars and how it positively affects the businesses and communities of the towns that have such cars. Mr. Williams updated the Council that with fundraising and other means of collecting money, the pilots and the Airport have raised roughly \$3,200 to purchase a car. Also, they have managed to acquire an insurance quote of \$900 a year. F. Trump expressed his thoughts to Mr. Williams on the subject of the courtesy car, and he feels that it is a great idea and believes we should continue pursuing the idea with further information about policies. The topic was kicked to the Public Works Committee for further discussion.

Diane Levan spoke with Council on matters of the Town Pool being closed next season due to maintenance that needs to occur. Ms. Levan asked Council to table their decision on the Town Pool until after the election. Her reasoning is she feels that if a new Council is elected they might feel differently about the pool then the current Council does.
