A regular meeting of Bloomsburg Town Council was held Wednesday, December 21, 2011, beginning at 6:00 p.m. in Council Chambers, Town Hall, 301 East Second Street, Bloomsburg, PA. Present were Mayor Daniel Knorr; Council Members Diane Levan, Paul Kinney, Sylvia Costa, William Kreisher and Claude Renninger; Town Administrator Carol Mas and Director of Finance Heather Jacoby.

CITIZEN TO BE HEARD – CHARLES WAGNER

Charles, President of the Town Park Improvement Association (TPIA), presented an inspection report of Kidsburg conducted by Play by Design, LLC. The flood contributed to the failing condition of the structure. It would take around \$25,000 to repair the playground which may extend the life another year or two. The flood also saturated the fibar to the point where 12" would have to be removed and replaced added to the cost of the repair. The TPIA decided it would be in everyone's best interest to set aside the funds it would take to repair the structure and put it towards a replacement for the entire structure. A fundraising campaign for the replacement would begin. On a motion by P. Kinney, seconded by S. Costa and voted on unanimously, Council approved the TPIA to demolish Kidsburg in 2012 and to waive any demolition permit fees.

MAYOR'S UPDATE

Mayor Knorr presented a Certificate of Appreciation to Council Member Claude Renninger for lending his experience the past four months by completing the term left vacant by Kathy Shepperson. The Mayor also presented a plaque thanking Council Member Paul Kinney for his eight years of service on Council.

APPROVAL OF 2012 BUDGET

Mayor Knorr announced that there will not be a tax increase and reviewed various line items in the budget. P. Kinney asked is another police officer was needed. C. Howell noted that the benefits for full-time employees add to the town's cost as well as the pension liability. C. Renninger noted that the budget is a guide and any item can be discussed prior to action including an additional hire. On a motion by D. Levan, seconded by C. Renninger and voted on unanimously, Council approved the 2012 Budget as presented.

ADOPTION OF ORDINANCE NO. <u>943</u> – TAX LEVY FOR 2012

On a motion by C. Howell, seconded by D. Levan and voted on unanimously, Council adopted Ordinance No. 943 adopting the Tax Levy for 2012. The rate of this tax is fixed at 7.159 mills for general Town purposes, .732 mill for debt service, .380 mill for fire protection, .200 mill for the Bloomsburg Public Library and 1.350 mills for street lighting.

ADOPTION OF ORDINANCE NO. <u>944</u> – AMENDING CERTAIN SECTION OF CHAPTER 15 OF THE CODE OF ORDINANCES

On a motion by D. Levan, seconded by S. Costa and voted on unanimously, Council adopted Ordinance No. 944 amending certain sections of the motor vehicle and traffic regulations in force as set forth in Chapter 15 of the Code of Ordinances.

APPROVAL OF DECEMBER 12, 2011 COUNCIL MEETING MINUTES

On a motion by P. Kinney, seconded by S. Costa and voted on unanimously, Council approved the December 12, 2011 Council meeting minutes with no additions or corrections.
