5. The proposed bottom of Basin 1 shall have a minimum slope of one and a half percent (1.5%). (Section 22-802.3.J).

6. All proposed drainage pipes shall have a minimum diameter of fifteen inches (15") (Section 22-803.2.A.(4)).

Speaking on behalf of many individuals who utilize the Bloomsburg Municipal Airport known as N13, on a frequent basis, we wish to share some observations regarding the amazing operation and management of our airport; and what a vital resource it is for the community. Recently a number of us have had the opportunity to contribute our services to the day to day operation of N13 and witness first-hand the intensity of work that goes on every single day. Knowing not all council members are able to frequent the airport, or be there during times of high activity we felt this a prime time to make you aware of the level of work that goes into managing N13, and to highlight the exceptional work that the Airport Manager does on the Town's, and really the region's, behalf.

Our community airport has developed a reputation as a choice destination for pilots and those traveling for business and pleasure into our area. Pilots put N13 on their flight plans as opposed to other nearby airports due to the customer service, amenities, and family-like treatment they receive when they arrive. Just like your favorite restaurant or hardware store, airports have a "Yelp-like" review system. The positive comments and feedback shared give a ringing endorsement to others that they will have a great experience when they come to Bloomsburg. For those of us who get the opportunity to visit a lot of other airports of similar size, and even larger. it is rare to find another airport that comes close to the level of professionalism and service provided at N13.

The on-going management of the airport, the improvements that have been made in the last few years, the scouring for funding sources, grants, and opportunities for the betterment of N13 all contribute to improvements in economic development and drawing visitors for tourism and business to our Town and the general area. Pilots from other communities with airports of their own choose to rent hangar space and purchase fuel here at N13 because the opportunities offered beyond what is available elsewhere. Our Airport Manager serves on 2 aviation boards. They are the only person representing General Aviation on these boards in the entire state of PA and they have been chosen in part due to the progressive nature of Bloomsburg's airport.

Beyond the positive economic impact the airport operations provide, there is a sense of community and family that permeates all the interactions. This welcoming vibe resonates with our visitors and keeps them coming back. You can see this in examples such as comments on the airport visitors log saying, *"landed to get fuel and to visit with BJ!"* Events such as Community Day, the Dream Machine car show, the Scout Explorer Post and Civil Air Patrol events, collaborations with the Children's Museum, work with local school district's STEM programs; and our Young Eagles, EAA Chapter, Flying Club and Flight School, and frequent use of the conference room by local organizations, are just a few ongoing activities that demonstrate that inclusive culture, and that the airport is a resource for the entire community, not just pilots.

Accomplishing all of this and maintaining the high-level of service is no easy feat. The day to day work that goes into managing airport operations; the balancing of FAA regulations, Town requirements, and airport customer needs is mind-bogglingly complex. The fact that one person leads all of this is beyond comprehension. It is a 24-7, 365 day a year operation that somehow gets done exceedingly well. Knowing the Airport Manager as we do, they will give credit to the amazing team that surrounds them, and the exceptional support and partnership received from their co-workers, pilots, and community members. However it is clearly the Vision of the Airport Manager that encourages and garners the willingness for all of those individuals, including those contributing to this message tonight, to give of their time and their talents towards the success of N13.

Our hope is that this message encourages you to recognize the amazing resource our Town has in the Municipal Airport, and to acknowledge the exceptional and extensive work that goes into its operations. If you haven't visited the airport in a while, stop down and see what takes place. You will likely be very impressed; and you should be very proud to call N13 YOUR Municipal Airport.
