On a motion by T. Bell, seconded by N. McGaw, and voted on unanimously, Council approved to accept Steve Hummel's resignation from the Bloomsburg Human Relations Commission. Council expressed their appreciation of Hummel's service.

APPROVAL TO APPOINT MARIA VALENTIN TO THE BLOOMSBURG HUMAN RELATIONS COMMISSION WITH A TERM ENDING 12/31/2024.

On a motion by J. Garman, seconded by T. Bell, and voted on unanimously, Council approved appointing Maria Valentin to the Bloomsburg Human Relations Commission with a term ending 12/31/2024.

RECOMMENDATION TO APPROVE A DONOR SIGN AT THE DOG PARK TO BE DISPLAYED AS \$100, \$500, \$1,000+ TIERS.

On a motion by T. Bell, seconded by N. McGaw, and voted on unanimously, Council approved a donor sign at the dog park to be displayed as \$100, \$500 and \$1000+ tiers.

APPROVAL OF A TRAFFIC SIGNAL MAINTENANCE AGREEMENT.

On a motion by N. McGaw, seconded by B. Crawford, and voted on unanimously, Council approved the Traffic Signal Maintenance Agreement.

APPROVAL OF A MEMORANDUM OF UNDERSTANDING BETWEEN COLUMBIA COUNTY CONSERVATION DISTRICT AND THE TOWN OF BLOOMSBURG.

On a motion by N. McGaw, seconded by J. Garman, and voted on unanimously, Council approved a memorandum of understanding between Columbia County Conservation District and the Town of Bloomsburg.

RECOMMENDATION TO APPROVE MOVING FORWARD WITH DRAFTING AN ORDINANCE TO ALLOW A GRACE PERIOD FOR LICENSING REGULATED RENTAL UNITS.

On a motion by N. McGaw, seconded by B. Crawford, and voted on unanimously, Council approved moving forward with drafting an ordinance to allow a grace period for licensing regulated rental units.

Council adjourned the meeting into an executive session at 7:30 p.m. regarding a pool personnel matter, a litigation matter and a union negotiation matter. The meeting reconvened at 8:24 p.m.

On a motion by T. Bell, seconded by N. McGaw, and voted on unanimously, Council approved the lifeguard starting rate at \$11.00 per hour, without experience and \$12.00 per hour with experience.

On a motion by T. Bell, seconded by N. McGaw, and voted on unanimously, Council adjourned the meeting at 8:25 p.m.

Lisa Dooley Town Manager/Secretary/Treasurer I have been attending town meetings for many years. Two decades of civic involvement including dozens of Planning Commission and Historical Architectural Review Board events, and probably over a hundred Town Council meetings, have exposed me to a lot of the workings of local government.

Over time I have witnessed first hand much debate regarding all kinds of concerns including zoning, planning, parking, student housing and university relations. The nuts and bolts discussions involving finances, maintenance, and ordinances while sometimes tedious - help explain decisions made and actions taken.

I have experienced five different mayors and dozens of council members, as well as numerous administrators. I have enjoyed all the various personalities and styles of both officials and citizens. Of course I did not always agree with folks, but I always respected them. When there was disagreement, I could at least understand their views because I was present at, and participated in, many of the meetings. I asked questions, or expressed concerns, and would then get immediate feedback. That way I was involved in, and had a better understanding of, the outcome.

That is how representative government works. Different ideas can be presented. examined, and argued - but when after due diligence, choices are made by elected officials - the decisions should be honored. Of course in this country, we do have the right to appeal and challenge, but there is a proper way to do that.

My point in submitting this is to state that during discussion and debate. I think it is appropriate and necessary that opposing views be shared - especially by those who will be deciding, and voting, on something of significance. While it's hard to endure relentless, unyielding advocacy for an item that might be voted against, it is even more exasperating to hear a "nay" vote from a member who did not share their arguments, and reasons, during the discussion. I understand those members are not obligated to explain their position, but would that not make more sense? In closing, I am requesting opposition to proposals be revealed and explained by council members prior to voting on them.

Finally, I want to express appreciation for all that council and other committee members do. They perform a tough and sometimes thankless job.
