#### ORDINANCE NO. \_\_\_\_\_ OF 2022

# AN ORDINANCE OF THE TOWN OF BLOOMSBURG VACATING AND ABANDONING A PORTION OF MILLER AVENUE LOCATED IN THE TOWN OF BLOOMSBURG, COLUMBIA COUNTY, PENNSYLVANIA

**WHEREAS**, pursuant to the Borough Code (8 P.S. §1731 <u>et. seq.)</u>, Bloomsburg Town Council has the authority to vacate or close a street or portion of a street previously opened or laid out; and

**WHEREAS,** pursuant to Section §1731 (a)(2) of the Borough Code vacation of a street terminates the public right in or to the street; and

**WHEREAS,** that portion of Miller Avenue to be vacated is more particularly described on Exhibit "A" appended hereto; and

**WHEREAS,** that portion of Miller Avenue to be vacated is more particularly depicted on the Existing Conditions Plan appended hereto as <u>Exhibit "B"</u>; and

**WHEREAS,** after due notice The Bloomsburg Town Council has determined that it is prudent and advisable to vacate the above-described portion of Miller Avenue.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by The Bloomsburg Town Council of Bloomsburg, Columbia County, Pennsylvania as follows:

<u>Section 1:</u> The Bloomsburg Town Council does vacate and abandon all that certain piece, parcel or tract of land comprising a portion of Miller Avenue described on <u>Exhibit "A"</u> which is attached hereto and made a part hereof as though fully set forth herein. A plan showing the location and width of the piece, parcel or tract of land which is being vacated and abandoned is depicted on <u>Exhibit "B"</u> and made a part hereof as though fully set forth herein.

Section 2: It is the intention of The Bloomsburg Town Council that adoption of this Ordinance shall vacate the said area described and depicted in the Exhibits appended to this Ordinance with the same force and effect as if it had never been laid out or used as a public street in the Town of Bloomsburg.

<u>Section 3:</u> This Ordinance specifically repeals any and all Ordinances or maps inconsistent herewith.







Delta reviewed the bids for the referenced project. There were two bids submitted for both the Base Bid (AIP Work) and Bid Additive1 (Non-AIP Work) as presented in the enclosed Bid Tabulation.

CriLon Corp. submitted the apparent low bid for the Base Bid (AIP Work – and basis for award), Bid Additive 1 (non-AIP work), and the Total Bid (AIP & Non-AIP Work) as follows:

Total Bid (AIP & Non-AIP Work)	\$ 209,781.03	\$ 254,400.00	\$ 251,100.00

The apparent low bid submitted by CriLon is 19.3% below the Engineer's Opinion of Probable Construction Cost (EOPCC) for Base Bid (AIP Work) and 16.5% below the EOPCC Total Bid (AIP & Non-AIP Work). The second bidder, Axtell's. submitted a bid at 1.1% below the EOPCC Base Bid (AIP Work) and 1.3% above the EOPCC Base Bid Total (AIP & Non-AIP Work).

Below is a summary of our findings following the review of the Bid Proposals:

#### CriLon Corp.

1. Pages 23 through 28 - The bidder check marked (on page 25) they were unable to meet the subcontracted Disadvantaged Business Enterprise (DBE) goal of 5.31% DBE and are committed to a minimum of 4.77% DBE utilization on the project. Their documented DBE subcontractor backup lists one DBE firm with a DBE estimate of work totaling \$10,000.00 which equates to 5.07% DBE participation against their Base Bid (AIP Work). The quoted 4.77% DBE utilization was calculated based on their total bid including both AIP and non-AIP work. However, the DBE goal applies only to AIP work. They did not however include any Good Faith Effort (GFE) backup to show whether other DBE firms were contacted.

> In accordance with Paragraph A12 of Section 200, the submission of good faith efforts was noted as a condition of bid responsiveness and was specified to be submitted with the bid proposal. Please note that 49 CFR Paragraph 26.53 (b)(3)(i) allows an option for the Contractor to submit their required good faith effort information, no later than 5 days from bid opening.

2. Page 48 - The bidder completed the Section 20-02 Proposal Requirements Checklist but did not include the evidence of competency or financial responsibility required to be furnished as part of their Bid Proposal.

#### Axtell's Pavement Solutions, LLC

- 1. Pages 9 through 11 The Bidder exceeded the maximum 10% Mobilization as stipulated in the Bid Documents (Section 20-03 Contents of proposal forms). Note that Item C-105 Mobilization contains language defining the method of payment for costs over the stated 10% maximum on an as-incurred basis.
- 2. Page 21 The bidder signed the Certification of Offerer/Bidder Regarding Tax Delinquency and Felony Convictions but did not check the actual Certification statements as required.

The Town and their Solicitor should review the Bid Tabulation, the Bid Proposals, and the appropriate sections of the Bid Document requirements to determine the lowest responsive bidder. We have enclosed relevant information for your review of these items.

If you wish to have a call to discuss these items, I am happy to make myself available so that we can reach out to contractors if needed. Once you have confirmed a responsive bid, Delta will prepare the appropriate documents to be submitted to the PennDOT BOA for securing the additional funding for the project. No Award will be made until the grant amendment has been approved for the project.

# AN ORDINANCE OF THE TOWN OF BLOOMSBURG VACATING AND ABANDONING FRANKLIN STREET LOCATED IN THE TOWN OF BLOOMSBURG, COLUMBIA COUNTY, PENNSYLVANIA

WHEREAS, pursuant to the Borough Code (8 P.S. §1731 et. seq.), Bloomsburg Town Council has the authority to vacate or close a street or portion of a street previously opened or laid out; and

WHEREAS, pursuant to Section §1731 (a)(2) of the Borough Code vacation of a street terminates the public right in or to the street; and

**WHEREAS,** the area comprising Franklin Street to be vacated is more particularly described on Exhibit "A" appended hereto; and

**WHEREAS**, the area of Franklin Street to be vacated is more particularly depicted on the map appended hereto as Exhibit "B"; and

**WHEREAS,** after due notice The Bloomsburg Town Council has determined that it is prudent and advisable to vacate the above-described Franklin Street.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by The Bloomsburg Town Council of Bloomsburg, Columbia County, Pennsylvania as follows:

Section 1: The Bloomsburg Town Council does vacate and abandon all that certain piece, parcel or tract of land comprising Franklin Street described on Exhibit "A" which is attached hereto and made a part hereof as though fully set forth herein. A plan showing the location and width of the piece, parcel or tract of land which is being vacated and abandoned is depicted on Exhibit "B" and made a part hereof as though fully set forth herein.

Section 2: It is the intention of The Bloomsburg Town Council that adoption of this Ordinance shall vacate the said area described and depicted in the Exhibits appended to this Ordinance with the same force and effect as if it had never been laid out or used as a public street in the Town of Bloomsburg.



ORDINANCE NO. <u>858</u>

AN ORDINANCE REGULATING THE USE OF BICYCLES AND SELF-PROPELLED RECREATIONAL DEVICES IN THE TOWN OF BLOOMSBURG; REQUIRING THE REGISTRATION OF BICYCLES AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

#### **BICYCLES**

#### Section 100-1 - Definitions

BICYCLE - A two-wheeled, in tandem vehicle, either wheel of which is 20 inches or more in diameter, operated by human power, but excluding any power-driven vehicle which is required to be licensed under the laws of the Commonwealth of Pennsylvania.

#### Section 100-2 - Registration and license required

No person who resides within the Town of Bloomsburg shall operate a bicycle upon any street, alley, or public place within the Town of Bloomsburg unless the same has first been properly registered and has affixed thereto a license issued by the Town of Bloomsburg Police Department.

#### Section 100-3 - Registration form; execution and filing

Every owner of any bicycle within the Town of Bloomsburg shall, within 10 days of acquisition of such bicycle, file with the Town of Bloomsburg Police Department a description of the bicycle upon a form to be provided for that purpose. Upon the execution and filing of the

form, the same shall constitute a registration of such bicycle. All registrations shall be serially numbered and filed by the Town of Bloomsburg Police Department.

#### Section 100-4 - License attachment by Police

Upon the registration of a bicycle in accordance with this Part, the Town of Bloomsburg Police Department shall affix a license, serially numbered so as to correspond with the registration of such bicycle, in a prominent place thereon.

#### Section 100-5 - Registration term

The registration of each bicycle shall be permanent and need not be renewed with the exception of the following circumstances:

A. If the bicycle is sold or transferred to a new owner, it shall be the duty of the new owner to have the bicycle registered in his or her name and to have a new license issued therefor.

B. If the original license has been mutilated or destroyed so as to be unreadable, the owner thereof shall obtain a new license and registration therefor.

#### Section 100-6 - Evidence of ownership; license refusal for unsafe condition

The owner of each bicycle, at the time of registration or re-registration, shall present the Police Department of the Town of Bloomsburg evidence of ownership of the bicycle, satisfactory to the Police Department. The Police Department may refuse to license a bicycle which it deems to be in an unsafe mechanical condition.

#### Section 100-7 - License fee

The fee for registration or re-registration of each bicycle shall be set by Resolution of the Town Council of the Town of Bloomsburg from time to time and shall be paid at the time

the license therefor is issued.

#### Section 100-8 - License nontransferable; change of ownership

All registrations and licenses issued hereunder are not assignable. Within 10 days after any bicycle has changed ownership or been dismantled, such information shall be reported to the Police Department of the Town of Bloomsburg by the former owner, and the new owner shall register the bicycle and receive a new license therefor.

#### Section 100-9 - Operation without license or in unsafe manner

No person shall operate any bicycle which is not properly registered or which fails to have a proper license as required herein, or operate a bicycle in an unsafe manner.

#### Section 100-10 - Riding or parking to obstruct pedestrians

A. No person shall ride a bicycle upon any sidewalk, park, school yard, or any public place so as to obstruct pedestrian traffic or endanger another person's safety. No person shall park or let a bicycle stand upon any sidewalk, park, path, or any public place where it is an obstruction to pedestrians.

B. No person shall ride a bicycle on the sidewalk of the following streets, except for members of the Police Department of the Town of Bloomsburg, including the Chief of Police, while on duty: Main Street, from Railroad Street to East Street; East Street, from Third Street to Main Street; and Market Street, from Third Street to First Street.

#### Section 100-11 - Passengers prohibited

No operator of any bicycle shall carry more persons at one time than the number for which the bicycle is designed and equipped with the exception of seats attached for carrying small children.

#### Section 100-12 - Lights and reflectors

Every bicycle operated upon a street, alley, or public place within the Town of Bloomsburg between one-half hour after sunset and one-half hour before sunrise shall be equipped with a battery-powered or generator-operated lamp on the front, exhibiting a light to the front of the bicycle visible for a distance of 500 feet, and equipped with a battery-powered lamp or red reflector on the rear which shall be visible for a distance of 500 feet to the rear.

#### Section 100-13 - Brakes

Every bicycle shall be equipped with brakes in proper working order.

#### Section 100-14 - Compliance with traffic laws required

No person shall operate a bicycle on any street or public alley in the Town of Bloomsburg in violation of any traffic ordinance of the Town of Bloomsburg or law of the Commonwealth of Pennsylvania.

#### Section 100-15 - Violations and penalties

Any person violating any provision of this Part shall, upon conviction thereof, be fined not more than \$50. A bicycle operated by any person in violation of this Part because of the lack of a registration may be impounded by the Police Department of the Town of Bloomsburg, at its discretion, until such bicycle is registered as herein provided.

#### SELF-PROPELLED DEVICES

#### Section 200-1 - Definitions

As used in this Part, the following terms shall have the following meanings:

ROADWAY - That portion of the highway designed or ordinarily used for

vehicular travel, excluding sidewalks.

SELF-PROPELLED RECREATIONAL DEVICE - Any wheeled vehicle that is self-propelled either by human power or by motor, including but not limited to skateboards, tricycles, unicycles, scooters, roller skates or roller blades, but excluding therefrom bicycles as set forth in the Bicycle portion of this Ordinance. Devices such as wagons or baby carriages, which are propelled by means external to the device, shall not be considered a self-propelled recreational device under this Ordinance.

SIDEWALK - That portion of the highway designated or ordinarily used for pedestrian travel.

#### Section 200-2 - Rules of the road

A. No person shall ride a self-propelled recreational device upon any sidewalk, park, school yard, or any public place or any roadway so as to obstruct pedestrian traffic or endanger another person's safety, or ride a self-propelled recreational device on any highway, street, or roadway in such a manner so as to impede the normal flow of vehicular traffic.

- B. No person shall let a self-propelled recreational device stand upon any sidewalk, park, path, roadway, or any public place where it is an obstruction or hazard to pedestrians.
- C. No person shall ride a self-propelled recreational device onto or from any bench, chair, flower box, retaining wall, or other public accessory or structure which is not intended for pedestrian foot traffic, or any stairway or any area or space intended only for pedestrian foot traffic.
  - D. No ramps, rails, or similar devices shall be used on any street, right-of-way,

parking lot or sidewalk and no person shall use such ramps, rails, or similar devices in such a manner to cause the person to land on a street, right-of-way, parking lot, or sidewalk.

- E. No person or pedestrian shall ride or operate a self-propelled recreational device on a sidewalk on the following streets: Main Street, from Railroad Street to East Street; East Street, from Third Street to Main Street; and Market Street, from Third Street to First Street.
- F. No person shall operate or ride a self-propelled recreational device on any roadway where the volume of speed of the vehicular traffic or the width of the roadway renders the roadway unsafe or unsuitable for self-propelled recreational devices.
- G. Self-propelled recreational device operators on sidewalks and roadways shall yield the right-of-way to all vehicular and other pedestrian (non-self-propelled recreational device) traffic upon the sidewalk or roadway.
- H. No more than one person shall operate or ride on a self-propelled recreational device at one time.

#### Section 200-3 - Compliance with other laws

No person shall operate a self-propelled recreational device on any roadway or public alley in the Town of Bloomsburg in violation of any traffic ordinance of the of the Town of Bloomsburg or the laws of the Commonwealth of Pennsylvania.

#### Section 200-4 - Violations and penalties

Every person convicted of violation of any provision of this Part shall be punished by a fine of not more than \$50 and shall be ordered to pay restitution should any damage or injury have resulted from the act giving rise to the violation of this Part.

#### **GENERAL PROVISIONS**

#### Section 300-1 - Severability

In the event that any provision of this Ordinance is declared unconstitutional, unlawful, or unenforceable by a Court of competent jurisdiction, such declaration shall not affect the validity of the remainder of this Ordinance or of this Ordinance as a whole, but such shall continue in full force and effect as though the unconstitutional, unlawful, or unenforceable provision had never been a part hereof.

#### Section 300-2 - Repealer

If any Ordinance or any part thereof is found to be inconsistent with this

Ordinance, it is hereby repealed. In addition, Chapter 3 of the Code of Ordinances of the Town
of Bloomsburg is hereby specifically repealed.

This Ordinance shall take effect immediately upon enactment.

- 1. The following areas have been assigned as handicapped parking only. Upon approval by the Town Council the Town of Bloomsburg may erect a reserved handicap space as close as possible to the residence of a person with a disability or who is a severely disabled veteran who has applied for a reserved handicap space. A fee to be determined by council from time to time will be required at the time of application. Reserved handicapped parking spaces will include the license plate number of the handicapped person's designated car.
- 2. In all other public parking areas where signs are posted with the designated international symbol for access for persons with disabilities only those with handicapped registration plate, handicapped parking placard, disabled veteran registration, or a disabled veteran placard shall be allowed permitted to park in these those handicap spaces areas:

3. The list of approved handicap spaces may be updated by a resolution of the Bloomsburg Town Council from time to time.

4. Any person violating this section shall pay at the office of the Chief of Police the sum of \$50 within 20 days of the date of the violation. If the sum of \$50 is not paid within 20 days of the date of the violation, a citation shall be filed in the Office of the Magisterial District Court, and upon conviction, the violator shall be sentenced to pay a fine of \$60 plus costs of prosecution.
