# Administrative/Finance Committee Minutes Wednesday, June 7, 2023, 10:00 a.m.

Justin Hummel called the meeting to order at 10:00 a.m., present were Council Members Bonnie Crawford, Vince DeMelfi, Toni Bell, Jim Garman, Town Manager/Secretary/Treasurer Lisa Dooley, Director of Finance Kim Pogash, Police Chief Scott Price, Director of Code Enforcement Mike Reffeor, Airport Coordinator BJ Teichman, and Administrative Assistant Christine Meeker. Also present was MJ Mahon.

Drew Pangborn updated the Committee on the energy savings for the Town. The Town can lock in a perceived better rate now for March 2024 per Drew.

On a motion by T. Bell, seconded by B. Crawford, and voted on unanimously, the Committee recommends Council approve to accept the 24-month rate of \$0.07255 for a contract period starting March 2024 with WGL energy.

#### Safety Committee Meeting Minutes Wednesday, June 14, 2023, 10:00 a.m. Airport Conference Room

The meeting was called to order by C. Fritz at 10:00 a.m. In attendance were members: Director of Governmental Services/Recycling Coordinator Charlie Fritz, Director of Code Enforcement Mike Reffeor, Town Hall Kyleigh Bilger, Airport Coordinator BJ Teichman, Recycling Dept. Michelle Hartzell, Public Works Kyle Hoffman, Tracy Kishbaugh- Police Town Hall. Members absent: Police Dept. Ken Auchter and Code Enforcement Greg Ash.

On a motion by T. Kishbaugh, seconded by M. Hartzell, and voted on unanimously, the group approved the May 10, 2023 minutes.

C. Fritz noted that there were no Workers Comp. or Liability claims.

The Committee thanked Kyleigh for her time on the Committee. As she has left her position with the Town the Safety Committee will have eight members moving forward the remainder of 2023, Quorum remains at 5 members.

The Committee reviewed this month's safety topic. Work in the Heat Safety handout from the PA Training for Health & Safety and the CDC. A copy of the handout was distributed to each department to hang on their bulletin board. The handout reviewed symptoms of heat exhaustion and heat stroke and provided reminders to stay hydrated, wear sun protection and light-colored clothing.

C. Fritz provided a link to www.Airnow.gov a site that provides the rating of the air quality that was prominent June  $6^{th}$  – June  $8^{th}$  in the event the situation reoccurs.

C. Fritz handed out the monthly safety theme for each department to post. This month's theme is **Safety Does Not Rely on Luck.** 

K. Hoffman reviewed the Park inspection completion report and noted the items to be addressed in the future. He noted that all handicap parking spaces throughout the Town parking areas will be painted next week. It was noted that the condition of Totsburg wood surround fence with the mulch ground covering is causing wear on the fence. Options would be to repair the damaged boards and seal all of the wood, or remove the surrounding fence. A conversation with the Town Park Improvement Association should also be done for their input.

- T. Kishbaugh brought up a concern with the gap in the floor between the elevator door and the floor. The gap is large enough for a phone, keys etc. to fall through all the way to the basement.
- T. Kishbaugh reminded the committee that the parking lot construction is soon to begin. It was noted that there is a lot of road construction occurring in the Town and the BART project will also be starting. Be careful when driving.
- C. Fritz brought up a request from a citizen regarding Catherine St. near the park/pool area. Can a sign or other traffic calming method be put in place. There are a lot of people walking in this location. Possibly a caution pedestrians sign could be put up.

K. Hoffman brought up a concern for bees/wasps/hornet nest around Kidsburg. Should the Town have Keystone spray regularly or should Public Works do a weekly/bi-weekly spray.
