**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE AMENDING CHAPTER 2 OF THE CODE OF ORDINANCES OF  
THE TOWN OF BLOOMSBURG ENTITLED "ANIMALS"**

**WHEREAS**, the Town of Bloomsburg (the "Town") enacted Chapter 2 of the Code of Ordinances of the Town of Bloomsburg (the "Code") which regulates Animals; and

**WHEREAS**, the Town desires to amend Chapter 2 of the Code as set forth herein.

**AND NOW be it ORDAINED and ENACTED** by the Bloomsburg Town Council, as follows:

1. The following shall be added to §2-101 "Terms Defined" of Chapter 2:

STREATER FIELD: that real property of the Town of Bloomsburg comprising 51.11 acres, more or less, being designated at Tax Parcel Number 05 W09 01100 and being more particularly described in Instrument Number 201307877 recorded in the Office of Recorder of Deeds in and for Columbia County, Pennsylvania.

2. Part 4 of Chapter 2 of the Code shall be amended to be titled as follows:

**Part 4**

**REGULATION OF ANIMALS IN TOWN PARK AND AT STREATER FIELD  
AND HOURS OF OPERATON**

3. Section 2-402 of Chapter 2 shall be amended to read as follows:

§ Section 2-402. Designation of Areas of Town Park, Streater Field and Hours of  
Operation of Town Park

1. It shall be unlawful for the owner or person in control of any animal of any type to cause or allow such animal, with the exception of household pets consisting solely of dog(s), at any time, to enter or be upon any portion of Town Park which extends north of the southern cartway of Fort McClure Boulevard. The owner or person in control of dogs in the foregoing portion of Town Park shall have the dog(s) leashed at all times. Notwithstanding the foregoing, no dogs shall be allowed within the confines of any playground area or baseball field in Town Park.
2. It shall be unlawful to have any household animal consisting of dog(s) on any portion of Streater Field (or the area in the immediate vicinity thereto) designated for soccer during any official American Youth Soccer Organization soccer game. Notwithstanding the foregoing, household animals consisting of dog(s) may be

present on any other portion(s) of Streater Field during American Youth Soccer Organization games.

3. It shall not be unlawful for the owner of person in control of any household pet or small animal to cause or allow such animals to enter or be upon any portion of Town Park which extends south of the southern cartway of Fort McClure Boulevard, so long as such owner or person in control of the household pet or small animal shall otherwise comply with the provisions of this Chapter.
4. Town Park and Streater Field shall be open to from dawn to dusk seven (7) days per week, subject, however, to such hours and days being changed by officials of the Town of Bloomsburg in the exercise of their discretion.

**Public Works & Environmental Committee Minutes**  
**Tuesday, February 6, 2024, 10:00 a.m.**

The meeting was called to order at 10:00 a.m. in attendance were Council members James Garman, Nick McGaw, Jessica Jordan (Zoom), Justin Hummel (Zoom), Town Manager/Secretary/Treasurer Lisa Dooley, Public Works Director John Fritz, Director of Code Enforcement Mike Reffeor, Airport Coordinator BJ Teichman, Director of Governmental Services Charles Fritz, Director of Finance Kim Pogash (Zoom), LEAA Elise Hughes and Administrative Assistant Christine Meeker (Zoom). Also in attendance were MJ Mahon, Dave Jones and Bob Stout.

Dave Jones from Delta Consultants outlined the proposed hangar project. This will be a phased project with funding through PennDOT Bureau of Aviation. Phase one will consist of environmental clearance, field work, airspace analysis and conceptual design. The Committee would like to see a revised break-even projection and a timeline to pull the plug.

On a motion by N. McGaw, seconded by J. Garman, and voted on unanimously, the Committee sends the airport hangar project to Council without a recommendation.

The Committee discussed rules at the Town Park, it was suggested that the park hours should be from dusk to dawn, dogs will be required to be leashed at all times within the Town Park area. The Town Solicitor will have a draft for the March meeting.

Elise Hughes outlined the items that require action for the new parking application signage, enforcement times, meter replacement and brochure updates.

On a motion by N. McGaw, seconded by J. Garman, and voted on unanimously, the Committee recommends Council approve the following items:

1. Changing the parking enforcement time from the 10:00 a.m. start to 9:00 a.m.
2. Approve a quote from Spike Gillespie in the amount of \$8,085 for 21 signs.
3. Approve the purchase of new meters from POM and the renting of meter changing device.

The Committee did not take action on the upgrading the parking brochures with Seven Mountain media for lack of a cost estimate.

On a motion by N. McGaw, seconded by J. Garman, and voted on unanimously, the Committee approved the minutes from the 1/9/2024 meeting.

On a motion by N. McGaw, seconded by J. Garman, and voted on unanimously, the Committee approved to hire a secondary compost site attendant at a rate of \$15 per hour.

The Committee reviewed the monthly reports for the Airport and Recycling Center.

Charles Fritz reported that South Centre Township contacted him regarding the use of the compost site for the township residents. L. Dooley suggested that the Town develop an agreement similar to the Scott Township service agreement. C. Fritz will report back at the next Committee meeting.

C. Fritz reported all paperwork for the boat launch project will be submitted by the end of the week. Pedestrian and traffic signs have been posted along the trail.

On a motion by N. McGaw, seconded by J. Garman, and voted on unanimously. The Committee recommends Council proceed with the tennis court project without the installation of lights. L. Dooley stated the bid package for the project will be structured to include an option for the inclusion of lights should the School District decide to provide funding.

L. Dooley, C. Fritz and J. Fritz reported on possible alternate sites for the pickle ball courts. A closer look will be taken of these sites during the engineering phase.

On a motion by N. McGaw, seconded by J. Garman, and voted on unanimously, the Committee adjourned the meeting at 12:05 p.m.

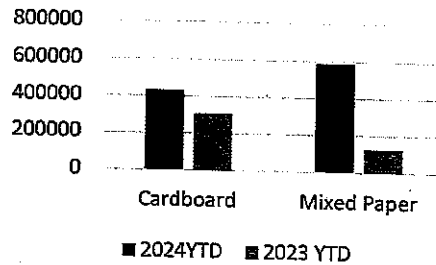
2024/2023 Comparison



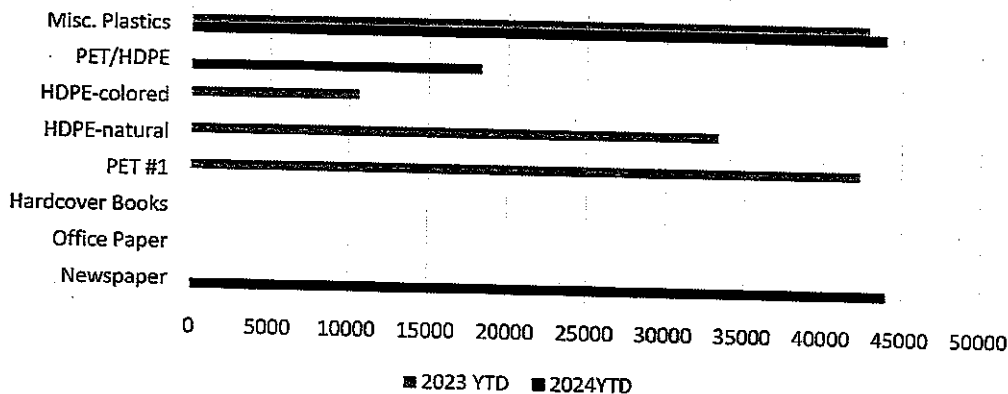
