Administrative/Finance Committee Minutes Wednesday, May 8, 2024, 10:00 a.m.

The meeting was called to order at 10:00 a.m., present were Council Members Toni Bell (Zoom), Bonnie Crawford, Jaclyn Kressler, Justin Hummel and Jim Garman (Zoom). Town Manager/Secretary/Treasurer Lisa Dooley, Police Chief Scott Price, Director of Public Works John Fritz (Zoom), Director of Code Enforcement Mike Reffeor, Director of Governmental Services Charles Fritz (Zoom), Airport Coordinator BJ Teichman (Zoom), Administrative Finance Receptionist Rachel Hager and Administrative Assistant Christine Meeker (Zoom). Also present was MJ Mahon.

On a motion by T. Bell, seconded by J. Kressler, and voted unanimously, the Committee approved the minutes from the April 3, 2024 meeting.

On a motion by T. Bell, seconded by J. Kressler, and voted on unanimously, the Committee approved the April list of vendors.

On a motion by J. Kressler, seconded by B. Crawford, and voted on unanimously, the Committee recommends Council approve the April list of bills.
