# Administrative/Finance Committee Minutes Wednesday, August 7, 2024, 10:00 a.m.

The meeting was called to order at 10:00 a.m., present were Council Members Justin Hummel, Bonnie Crawford, and Jim Garman (Zoom). Director of Public Works John Fritz, Director of Governmental Services Charles Fritz, Town Manager/ Secretary/ Treasurer Lisa Dooley, Airport Coordinator BJ Teichman, Chief of Police Scott Buck, Administrative Finance Receptionist Rachel Hager, Director of Finance Jack Breech and Administrative Assistant Christine Meeker (Zoom). Also present were MJ Mahon, Dawn Moore and James Maquire. Absent were Jackie Kressler and Toni Bell.

On a motion by B. Crawford, seconded by J. Hummel, and voted on unanimously, the Committee approved swim parties at the Norris E. Rock Memorial Pool for August 19, 2024.

On a motion by B. Crawford, seconded by J. Hummel, and voted unanimously, the Committee approved the minutes from the July 10, 2024 meeting.

On a motion by B. Crawford, seconded by J. Hummel, and voted on unanimously, the Committee approved the July list of vendors.

The Committee reviewed the American Rescue Plan grant spending.

The Committee reviewed the 2025 budget requests from the various departments. Discussion of parking meters vs passport revenues was requested to be discussed at the next Community & Economic Development/ Public Safety Committee.

Discussion of pavilion rentals. People are calling and requesting staff to make the reservations for pavilions. L. Dooley will contact LIVIC Civil to look at installing a blocking mechanism for double bookings and for the system to allow to block out reserved times.

The Committee discussed the need to replace two police vehicles. L. Dooley suggested downsizing the fleet.

The Committee discussed current staffing and future staffing in various departments. Lisa Dooley requested direction on the non-union raises and future staffing. Committee requested spreadsheets for a department's showing future raises and employee costs.

L. Dooley presented a PowerPoint to explain the operations of the future fuel farm. J. Hummel questioned the future requirement of using credit cards. L. Dooley is requesting a separate meeting to discuss merchandise fees associated with credit card use. BJ Teichman would like to grant a proprietary card for the flight school. Justin and Jim will sit in on the meeting.

A motion to adjourn was made by B. Crawford, seconded by J. Hummel, and voted on unanimously, the meeting adjourned at 1:00 p.m.

The meeting adjourned into an executive session at 12:56 p.m. and ended at 1:29 p.m. for police and airport personnel matters.
