**WHEREAS**, pursuant to Resolution No. 12.18.2023.01 ("Enabling Resolution"), the Town Council of Bloomsburg implemented a Code Blue Emergency Policy during adverse winter weather conditions for those who may find themselves at risk for cold-related exposure due to lack of shelter or defects in at home heating systems.

**WHEREAS**, the Enabling Resolution provided for Town Council to enter into agreements with a non-profit organization to provide temporary shelter once the Mayor of the Town has declared a Code Blue Emergency, in accordance with its Code Blue Emergency Policy attached in Exhibit A to the Enabling Resolution;

**BE IT RESOLVED**, that the Town of Bloomsburg of Columbia County hereby identifies AGAPE, of Bloomsburg, Pennsylvania, as a non-profit to provide temporary shelter during a Code Blue Emergency, subject to entering into an Agreement with the Town.

**BE IT FURTHER RESOLVED**, that the Town Council shall hereinafter enter into agreement with AGAPE to memorialize this authorization, and with the language required to be included in such agreements outlined in the Enabling Resolution.

## **CODE BLUE EMERGENCY POLICY**

### **A. PURPOSE**

The purpose of the Code Blue Emergency Policy is intended to provide notice of adverse winter weather conditions to the general public and social services agencies that provide services to at-risk individuals living outdoors, on the streets, in parks or poorly insulated settings, and those who may find themselves at risk for cold related exposure due to defects in at home heating systems.

### **B. PROCEDURE FOR CODE BLUE EMERGENCY DECLARATION**

1. The administration Town of Bloomsburg shall be designated to evaluate weather forecasts and evaluate weather forecasts and advisories produced by the National Weather Service -- State College Office for the Columbia County area to determine if a Code Blue Emergency will need to be declared.
2. The threshold levels that need to be met for the declaration of a Code Blue Emergency as forecasted by the National Weather Service are as follows:
  - a. Temperatures of 32 degrees Fahrenheit or lower; or
  - b. The National Weather Service wind-chill temperature will be zero degrees Fahrenheit or lower for a period of two hours or more; or
  - c. Snow predictions of 12" or more are in the forecast; or
  - d. Anytime a combination of rain, sleet, snow, with temperatures of 32 degrees (with wind-chill) are forecasted.
3. Weather data used to make this determination will be saved and archived for future reference and documentation purposes. The National Weather Service Date shall be the sole indicator that will determine if a Code Blue declaration is declared by the Town.
4. In the event that the weather report lacks clarity or specificity, the staff person will seek clarification from the on-duty Meteorologist at the National Weather Service office in State College in determining whether to declare a Code Blue Emergency.
5. When qualifying weather conditions are expected, the staff person, in advance of the expected Code Blue, shall notify, by E-mail, the Bloomsburg Town Police and non-profit organizations that the Town has made agreements with.
6. In addition to the weather criteria outlined herein, the Town shall also have appropriately contracted for non-profit organization to provide the appropriate shelter for the at-risk individuals to visit for overnight shelter arrangements during the Code Blue Emergency Period declared.
7. The criteria will be evaluated and, if warranted at the Mayor's discretion, a Code Blue Emergency will be declared. The Mayor may -- but is not otherwise required to -- declare a Code Blue Emergency if the existence of the criteria provided herein as satisfied.

8. To the extent possible following the declaration of a Code Blue Emergency, the Town of Bloomsburg shall post the Code Blue Emergency on its emergency web-site along with all of its social media accounts.

OPENING REMARKS FOR CHAIR OF PUBLIC  
HEARING ON CABLE FRANCHISE RENEWAL**

Good evening. This is a public hearing regarding cable franchise renewal for the Town of Bloomsburg. The hearing is held pursuant to Section 626 of the federal Cable Act, which sets forth the process for franchise renewal. Our current franchise agreement with Service Electric is expiring and we have begun the process of negotiating a new franchise agreement with the cable operator. This public hearing is an important part of franchise negotiations, in which the Town seeks public comment on the cable operator's past performance and our community's future cable-related needs.

The purpose of this public hearing is to hear from citizens regarding the following:

1. The past performance of the cable operator; and
2. The Town's future cable-related needs.

Franchise renewal is the best opportunity for municipalities to assert their rights with respect to their cable operators and to obtain important benefits in return for granting the cable operators the right to use its public rights-of-way. These benefits include, but are not limited to, the following:

1. Strong and enforceable customer service standards;

2. A state-of-the-art cable system;
3. Protections of the public rights-of-way;
4. Franchise fees for the cable operator's use of the public rights-of-way and improved franchise fee accountability;
5. Reporting requirements on the cable operators;
6. Legal protections for the Town; and
7. Better mechanisms to enforce the franchise agreements.

These are just some of the potential benefits available through franchise renewal.


Citizens may address these items or any other cable-related items that are important to them. We will now open the hearing up to citizen comments. Thank you.

BAY is seeking to expand its facility to quadruple its childcare capacity and offer full-day infant care for the first time. This will significantly improve the ability of our community to reenter the workforce and provide additional financial security for their families. BAY not only keeps its rates at or below other service providers, but it offers state and private subsidies to low-income families to make childcare truly affordable.

On October 14, 2024, we were pleased that BAY presented its project to the Bloomsburg Town Council and requested that the Town of Bloomsburg serve as BAY's public applicant. On October 28, 2024, the Council passed a resolution to officially support the project and agreed to serve as the applicant. It is our hope that with your support, this project will come to fruition. ***We respectfully ask you to support this project in any way that you can.***

**A RESOLUTION OF THE TOWN OF BLOOMSBURG, COLUMBIA COUNTY, PENNSYLVANIA, EXPRESSING ITS SUPPORT FOR THE BLOOMSBURG AREA YMCA CHILDCARE EXPANSION PROJECT, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE STATEWIDE LOCAL SHARE ACCOUNT PROGRAM AS THE APPLICANT, REQUESTING GRANT FUNDING FROM THE COMMONWEALTH FINANCING AUTHORITY AND DESIGNATING OFFICIALS TO EXECUTE ASSOCIATED GRANT DOCUMENTS.**

**WITNESSETH**

**WHEREAS**, the Town of Bloomsburg, Columbia County, Pennsylvania (hereinafter, the “Town”) wishes to advance the Bloomsburg Area YMCA Childcare Expansion project (hereinafter, the “Project”); and

**WHEREAS**, the Bloomsburg Area YMCA (hereinafter, “BAY”) and its partners have conducted community assessments and outreach in 2023 and 2024 and found that a top priority of the Bloomsburg community is increasing affordable and accessible childcare; and

**WHEREAS**, BAY is planning to renovate and expand its existing childcare facility to increase capacity from approximately 25 children to 100 children; and

**WHEREAS**, BAY desires to obtain a Statewide Local Share Account (hereinafter, “LSA”) grant award from the Commonwealth Financing Authority (hereinafter, “CFA”) in the amount up to One Million Dollars (\$1,000,000.00) to pay for costs associated with the expansion of its childcare center; and

**WHEREAS**, the Town wishes to act as the Applicant for the purposes of the LSA grant application; and

**WHEREAS**, the LSA application requires a resolution formally requesting the grant, defining the project, designating officials to execute all documents, and identifying the grant amount requested.

**NOW THEREFORE BE IT RESOLVED**, by the Town of Bloomsburg, as follows:

1. The above recitals are incorporated herein by reference.
2. The Town hereby supports the Project and authorizes the preparation and submission of an LSA application for the Project, whereby the Town will serve as the Applicant.
3. The Town hereby requests a grant in an amount up to One Million Dollars (\$1,000,000.00) from the CFA’s LSA program to be used towards advancing the Project.

4. The Town of Bloomsburg does hereby designate the Town Manager, and the Mayor as officials authorized to execute all documents and agreements between the Town of Bloomsburg and the CFA to facilitate and assist in obtaining the requested grant.
5. The provisions of this resolution shall be severable, and if any of its provisions shall be held unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect the validity of any of the remaining provisions of this resolution.
6. This resolution shall be effective immediately upon adoption.
7. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.

The purpose of this letter is to request a second extension and contract amendment to the Town of Bloomsburg HOME Contract C000079850. According to the fully executed HOME Grant Agreement, Appendix A, all work and services were to be completed by the date referenced in the Special conditions section. The Bloomsburg Town Council is respectfully requesting a one-year extension of the current contract amendment date from May 19, 2025, to May 19, 2026.

The justification for this extension request is based upon the following:

An extension is being requested due to having funds available to allocate towards three projects that are already in process. Two projects were approved in April 2024 and a third project is set to be approved in September 2024. Two of these projects are going through the bidding process, and the third project is set to be approved and sent out for bid. Our current contractors are experiencing staff shortages and therefore the timeframe for completing projects is taking longer than expected. There has also been an issue with building materials and products being readily available.

Due to the timeliness of gathering qualified contractors for the housing projects and working through the necessary steps to complete the activity, we are requesting an extension for the above-mentioned contract. We have revised our Intake process, continue to advertise to expand our contractor pool and we continue to grow our current waitlist.

It is agreed that all other provisions and certification(s) of the Grant Agreement shall remain in full force and effect.
