MJ Mahon and representatives from RTI: Austin Peters, Dave Schaar, Thaddeus Smyda, Dominick Tureaud, and Northeastern Automated Technology Ron Zumerling, were also present.

On a motion by N. McGaw, seconded by J. Kressler, and voted on unanimously, the Committee approved the minutes from the July 17, 2024 meeting.
