On a motion by J. Garman, seconded by J. Kressler, and voted on unanimously, Council approved the annual action plan for the Community Development Block Grant application federal fiscal year 2025.

APPROVAL TO ACCEPT THE RETIREMENT OF THE DIRECTOR OF PUBLIC WORKS- JOHN FRITZ, WITH HIS LAST WORKING DAY BEING JULY 11, 2025.

On a motion by N. McGaw, seconded by B. Crawford, and voted on unanimously, Council approved to accept the retirement of John Fritz, Director the Public Works with his last working day being July 11, 2025. Council thanked Mr. Fritz for his many years of service to the Town.

APPROVAL OF A \$10,000 RECRUITMENT INCENTIVE FOR THE 2025 POLICE OFFICER HIRING.

and voted on 3 to 3, (Hummel, Kressler and Crawford voting yes, Garman, McGaw and Jordan voting no). The motion did not pass.

APPROVAL OF AWARDING A BID FOR CONSTRUCTION WORK REGARDING THE PICKLEBALL COURT PROJECT AT STREATER FIELD.

On a motion by N. McGaw, seconded by B. Crawford, and voted on unanimously, Council approved awarding the bid for the pickleball courts project to Robert C. Young- base bid of \$242,474.20 and alternate perimeter fencing for \$37,350. Total= \$279,824.20.

APPROVAL OF AWARDING A BID FOR ENGINEERING SERVICES REGARDING THE MARKET STREET PAVING FOR 5TH STREET TO FT. MCCLURE BLVD.

On a motion by N. McGaw, seconded by J. Kressler, and voted on unanimously, Council approved awarding the bid for engineering services for the Market Street paving project to LIVIC Civil in the amount of \$48,000.

APPROVAL OF SUBMITTING AN APPLICATION FOR THE APPALACHIAN REGIONAL COMMISSION ACCESS ROAD PROJECT. NOTE: THIS WOULD BE A NEW ROAD PROJECT TO RELOCATE FT. MCCLURE BLVD. AT ROUTE 11 AND HAVE AN OPPORTUNITY FOR A TEMPORARY RED LIGHT PLACEMENT.

THE CLOSURE WOULD RUN FROM 3 P.M.- 8 P.M. NOTE: CHIEF FOSSE VOICED SOME RESERVATIONS ON THIS CLOSURE DUE TO THE INCREASED AMOUNT OF TRAFFIC THAT WILL BE IN TOWN BECAUSE OF THE FAIR.

Kressler, and voted on unanimously, Council approved the street closing of Center Street from Pine Avenue to Main Street on Saturday, September 27, 2025 to allow BTE to hold a gala to celebrate the opening of the Bloomsburg Theatre Ensemble 48th season. This closure would run from 3 p.m. to 8 p.m.

RECOMMENDATION TO APPROVE AN ORDINANCE AMENDMENT FOR CHAPTER 15 FOR MOTOR VEHICLES AND TRAFFIC RELATED TO PAID PARKING ON SECOND STREET/MAIN STREET BETWEEN WEST AND JEFFERSON STREETS.

On a motion by N. McGaw, seconded by B. Crawford, and voted on unanimously, Council approved an ordinance amendment for Chapter 15 for Motor Vehicles and Traffic related to paid parking on Second Street/Main Street between West Street and Jefferson Streets.
